#### **RESPONSIBILITIES:**

This is semi-skilled level work in the care and supervision of patients at a state mental health facility. Employees assist residents in all areas of physical care and assume total responsibility for the hygiene of patients who are unable to independently perform such tasks. Other duties include general housekeeping assignments, participating in social and recreational activities for the residents, and writing nontechnical reports on patient's behavior and activity. General supervision is received from a Support Care Supervisor, Alternate Supervisor, shift leader, or nursing supervisor; supervisory responsibilities are not assigned to positions allocated to this job class.

### **EXPERIENCE/EDUCATIONAL REQUIREMENTS:**

Must provide proof of Graduation from an accredited four-year high school or equivalent (GED or High School Equivalency Diploma).

Must have 0-1 years of experience in directly caring for IDD individuals or CNA type of work. (NO CNA license is required)
