CONTRACT TARGETED CASE MANAGER FOR COMMUNITY SUPPORT PROGRAM

WORK LOCATION: COMMUNITY SUPPORT DEPARTMENT – LONG BEACH

PAY: \$27 PER HOUR: UP TO 28 HOURS PER WEEK

SCHEDULE/SHIFTS: Monday through Friday 8:00AM to 4:30PM (variations as required)

CONTRACT TERM: July 1, 2024 through June 30, 2025

RESPONSIBILITIES: Serves as IDD Targeted Case Manager (TCM) for people enrolled in the IDD Community Support Program (1915i). Manages and maintains caseload of people receiving IDD Community Support Program services. Develops and maintains a person-centered Plan of Services and Supports (PSS) for each person on caseload. Revises/updates each person's PSS at least annually or when changes in the person's circumstances occur or when requests are made by the person/legal representative. Coordinates and monitors identified supports and services through regular monthly contact, face to face quarterly reviews, and annual assessment and re-certification meetings. Ensures services are adequate, appropriate, and meet the person's needs. Attention to detail, organizational and time-management skills, as well as the ability to articulate with written and verbal communication are required. Applies pertinent state and federal regulations as well as agency and program policy and procedures. Travel within the six southern counties is required.

EXPERIENCE/EDUCATIONAL REQUIREMENTS: Applicants must possess Bachelor's or Master's Degree in mental health, intellectual/developmental disabilities, or related field from an accredited 4-year college or university; and must have **at least one year of experience working** as a case manager or in related role **with people with IDD**. Must have a valid MS driver's license, or license from a contiguous state, and have personal vehicle insurance. Must be eligible to drive a State vehicle.

HOW TO APPLY: Completed Contract Application Packets **MUST** be hand delivered by May 10, 2024 to the Human Resource Department at 1170 West Railroad Street, Long Beach, MS 39560. All documentation verifying education and licensure MUST be submitted at the time of application.

This is a contract position with the State of Mississippi that STARTS 7/1/24 and will end 6/30/25. State contracts can be renewed/reapplied for every year.
